

2023 MSA Skeet League Rules

1. The league will consist of 800 targets; 100 targets per month, March thru October, and is open to all current and new members in good standing. Complimentary Limited Memberships (CLMs) will be provided at no cost for first time registered shooters for both the NSSA & MSA. You must sign-up for the league by March 15th.
2. Cost to enter the league is \$80, of which \$32 is for NSSA daily target fees; \$24 for MSA daily fees; and, \$24 for prize money. Fees must be submitted and made payable to "Rick Trawinski" when you register for the league.
3. Targets will be shot at "any MSA club", any day of the month you would like; in any increment, as long as you record 100 targets (i.e., 4, 25s; 2, 50s; or 1, 100). You are responsible for paying your club the cost of the rounds.
4. You must shoot your scores with at least one other league participant, and you cannot use scores from another registered event. However, if you are participating in a (non-registered) league at your club, those scores may be used towards your monthly total so long as you shoot a total of 100 targets.
5. League rounds must be declared prior to stepping onto the field.
6. Scores will be reported monthly, verbally or electronically, to Rick at ricktraw@gmail.com and must be received no later than the first day of the following month. Failure to report timely scores will result in a one bird per round (4 per 100) deduction from your score.
7. You may shoot ahead one month, but "catching up" is not allowed. In order to prevent handicaps from being skewed due to a participant failing to shoot all the required rounds in a given month, any "unshot" rounds will be entered as zero. Should he/she shoot all the required rounds in the following month, then the previous month's total will be adjusted to equal the total for the month just completed.
8. Targets will be reported as 12 gauge targets but can be shot with 12 gauge or smaller.
9. Targets shot will be recorded as "League Targets" and added to your NSSA Classification Card at the end of the year as the final event of the year in the 12 Gauge. Targets shot as part of the league will not affect a shooter's average or classification during the shooting year. See NSSA Rule Book (V-B-1-g) for additional information.
10. There will be two (2) Champions: "Scratch" and "Handicap" with additional places paid out depending upon participation. Prize money will be equally divided between the two divisions and paid out in accordance with the attached "MSA League Payouts" table.
11. Any ties in the scratch division will revert to the participant's handicap score to decide the tiebreaker. Being that the handicap division score is carried out to the hundredth decimal place, the chances there would be a tie are extremely minute.
12. League standings will be updated and posted monthly on the MSA website.
13. The League will be conducted on the *HONOR SYSTEM*. Any violations will be dealt with per the NSSA Rules of Conduct (NSSA Rules, Section VII).
14. Any protests or disputes will be submitted to, and addressed by, the MSA Board of Directors.
